CONDITIONS OF ENTRY

- A boat is entirely responsible for its own safety, whether afloat or ashore, and nothing, whether in the Notice of Race or Sailing Instructions or anywhere else, reduces this responsibility.
- ii. It is for the boat to decide if it is fit to sail in the conditions in which it will find itself. By launching or going to sea, the boat confirms that it is fit for those conditions and that its crew is competent to sail and compete in them.
- iii. The boat is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least one million pounds sterling.
- iv. Nothing done by the organisers can reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part of the racing. The organisers encompass everyone helping to run the race and the event, and include the organising authority, the race committee, the race officer, patrol boats and beach masters.
- v. The provision of patrol boats does not relieve the boat of its responsibilities.

DECLARATION

I agree to be bound by the ISAF Rules, the Sailing Instructions and the Class rules. I understand that the Organising Committee accepts no responsibility for loss of life or injury to members or others, or damage to any vessel or equipment. I hold and will produce a valid measurement certificate. I declare that I hold a valid and current certificate of insurance which covers me whilst racing including third party liability cover.
